FIRST READING: None.

SECOND READING:

2016-06 ORDINANCE OF THE BOROUGH OF GIBBSBORO AMENDING SECTIONS 96-1 AND 96-3 OF THE GIBBSBORO CODE BOOK BANNING THE SALE OF DOGS AND CATS FROM COMMERCIAL BREEDING FACILITIES AT PET SHOPS

WHEREAS, a significant number of puppies and kittens sold at pet shops come from large-scale commercial breeding facilities where the health and welfare of the animals are not adequately provided for (“puppy mills” and “kitten mills,” respectively). According to The Humane Society of the United States, it is estimated that 10,000 puppy mills produce more than 2,400,000 puppies a year in the United States and that most pet shop dogs and cats come from puppy mills and kitten mills; and

WHEREAS, the documented abuses endemic to puppy and kitten mills include over-breeding; inbreeding; minimal to non-existent veterinary care; lack of adequate and nutritious food, water and shelter; lack of socialization; lack of adequate space; and lack of adequate exercise; and

WHEREAS, the inhumane conditions in puppy and kitten mill facilities lead to health and behavioral issues in the animals bred in those facilities, which many consumers are unaware of when purchasing animals from pet shops due to both a lack of education on the issue and misleading tactics of pet shops in some cases. These health and behavioral issues, which may not present themselves until some time after the purchase of the animals, can impose exorbitant financial and emotional costs on consumers; and

WHEREAS, current Federal and State regulations do not adequately address the sale of puppy and kitten mill dogs and cats in pet shops; and

WHEREAS, restricting the retail sale of puppies and kittens to only those that are sourced from shelters or rescue organizations is likely to decrease the demand for puppies and kittens bred in puppy and kitten mills, and is likely to increase the demand for animals from animal shelters and rescue organizations; and

WHEREAS, according to the New Jersey Department of Health's 2014 Intake and Disposition Survey, due in large part to the pet overpopulation, more than 20,000 dogs and cats are euthanized in New Jersey animal shelters annually, including nearly 1,500 in the County of Camden. Restricting the retail sale of puppies and kittens to only those that are sourced from animal shelters and rescue organizations will likely reduce pet overpopulation and thus ease the burden on such agencies and financial costs on local taxpayers; and

WHEREAS, across the country, thousands of independent pet shops as well as large chains operate profitably with a business model focused on the sale of pet services and supplies and not on the sale of dogs and cats. Many of these shops collaborate with local animal shelters and rescue organizations to offer space and support for showcasing adoptable homeless pets on their premises; and

WHEREAS, this Ordinance will not affect a consumer's ability to obtain a dog or cat of his or her choice directly from a breed-specific rescue organization or shelter or from a hobby breeder where the consumer can directly see the conditions in which the dogs and cats are bred, or can confer directly with the hobby breeder regarding those conditions; and

WHEREAS, the Borough Council of the Borough of Gibbsboro believes it is in the best interests of the Borough of Gibbsboro to adopt reasonable regulations to reduce costs to the municipality and its residents, to protect the citizen of the Borough of Gibbsboro who may purchase dogs and cats from a pet shop or other business establishment, to help prevent inhumane breeding conditions, to promote community awareness of animal welfare, and to foster a more humane environment in the Borough of Gibbsboro.

NOW THEREFORE, BE IT RESOLVED, that Section 96-1 of the Gibbsboro Code hereby

replaces or adds the following to its list of definitions to be listed in alphabetical order and Section 96-3 of the Gibbsboro Code is replaced in its entirety:

§ 96-1 DEFINITIONS.

ANIMAL CARE FACILITY - An animal control center or animal shelter, maintained by or under contract with any State, county or municipality, whose mission and practice is, in whole or in significant part, the rescue and placement of animals in permanent homes or rescue organizations.

ANIMAL RESCUE ORGANIZATION - Any non-for-profit organization which has tax-exempt status under Section 501(c)(3) of the United States Internal Revenue Code, whose mission and practice is, in whole or in significant part, the rescue and placement of animals in permanent homes.

CAT - A member of the species of domestic cat, *Felis catus*.

DOG - A member of the species of domestic dog, *Canis familiaris*.

OFFER FOR SALE - A presentation for sale or adoption, an advertisement for the sale of, barter, auction, give away or otherwise dispose of a dog or cat.

PET SHOP - A retail establishment where dogs and cats are sold, exchanged, bartered or offered for sale as pet animals to the general public at retail. Such definition shall not include an animal care facility or animal rescue organization as defined.

§ 96-3 PET SHOPS, KENNELS, SHELTERS AND POUNDS.

A. Licensing of pet shops, kennels, shelters and pounds shall be in accordance with N.J.S.A. 4:19-15.14.

B. A pet shop may offer for sale only those dogs and cats that the pet shop has obtained from or displays in cooperation with:

1. An animal care facility; or
2. An animal rescue organization.

C. A pet shop shall not offer for sale a dog or a cat that is younger than eight (8) weeks old.

If any section, subsection, paragraph, sentence, clause or phrase of this Ordinance shall be declared invalid for any reason whatsoever, such decision shall not affect the remaining portions of this Ordinance which shall continue in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable. This ordinance shall become effective 90 days after passage.

2016-6-87 RESOLUTION SUPPORTING THE ADOPTION OF S2254/A3821 TO CLARIFY MUNICIPAL AFFORDABLE HOUSING OBLIGATIONS

WHEREAS, pursuant to the March 2015 New Jersey Supreme Court order which transferred oversight of the Fair Housing Act (FHA) to the courts, many municipalities (including South Brunswick) filed declaratory judgment actions to voluntarily comply with their present and prospective affordable housing requirements as established in the FHA; and

WHEREAS, the FHA and existing case law are clear that “present and prospective fair share of the housing need in a given region ... shall be computed for a 10-year period.” (See N.J.S.A. 52:27D-307(c)); and

WHEREAS, in October 2015, the Middlesex County Superior Court issued a decision that included a distinct “gap period” obligation, retroactively imposing an additional municipal obligation over an additional 16 year period, separate and apart from the normal 10 year present and prospective need set forth in the FHA. Recently the Ocean County Superior Court did the same. The Ocean County decision is currently on appeal; and

WHEREAS, this “gap period” issue arises out of COAH’s inability to promulgate third round regulations from 1999 to the present or make any final determination as to state and regional housing need. Despite this, the courts are not holding COAH accountable but rather are imposing additional obligations on municipalities. These retroactive obligations will have a significant and unfunded impact on municipalities, straining their already overburdened resources; and

WHEREAS, aside from other inequities and issues imposed by a so-called “gap” obligation, the households counted in the “gap period” may well be double counted when the present need is calculated. The prospect of double counting compounds this dilemma and will likely result in forcing municipalities and their property taxpayers to subsidize development or subject them to court orders allowing enormous numbers of new housing units as a result of “builder’s remedy” lawsuits. Such a result will radically and irrevocably transform the character and quality of life for all New Jersey residents; and

WHEREAS, hundreds of New Jersey’s municipalities have expended significant financial and other administrative resources in their attempts to voluntarily comply with their constitutional obligation for affordable housing as established by the Supreme Court and the FHA. As a direct result of the State’s failure to advance viable regulations or enact overdue legislative reform, this will only continue to spiral out of control; and

WHEREAS, Senate Bill S2254 and Assembly Bill A3821 are important legislative remedies designed to clarify existing law and preclude these significant, unfair impacts. Swift and decisive adoption of both is a critical step toward a more rational statewide housing policy, including reasonable and achievable obligations for municipalities;

NOW THEREFORE BE IT RESOLVED on this 8th day of June, 2016, by the Borough Council of the Borough of Gibbsboro, County of Camden, State of New Jersey, that:

1. The Mayor and Borough Council hereby support the adoption of Senate Bill S2254 and Assembly Bill A3821 to clarify that a municipality’s present and prospective fair share of the housing need in a given region shall be computed for a 10-year period, and shall not include a retrospective obligation arising from any so called “gap period.”
2. The Mayor and Borough Council urge the members of the New Jersey Senate, General Assembly and the Governor to swift and decisively adopt both as a critical step toward a more rational statewide housing policy, including reasonable and achievable obligations for municipalities.
3. A certified copy of this resolution be sent to Hon. Chris Christie, Governor; Hon. Stephen M. Sweeney, President, NJ Senate; Hon. Vincent Prieto, Speaker, NJ General Assembly; Hon. James Beach, NJ Senate; Hon. Louis D. Greenwald, NJ General Assembly; Hon. Pamela R. Lampitt, NJ General Assembly and the New Jersey State League of Municipalities.

PLANNING BOARD/PUBLIC WORKS **COUNCILMAN BONSAALL**
 Councilman Bonsall reported that the Planning Board meets next week. With regard to Public Works, everything is going well and equipment is fine.

PUBLIC EVENTS **COUNCILMAN BROWN**
 Miss Gibbsboro Pageant will be on Tuesday, June 28 at 7 p.m. It will be held at Lakeside Manor. All are invited to attend. The annual parade will be on July 4th with July 9th being the rain date.

TRASH & RECYCLING/HEALTH **COUNCILMAN DETERDING**
 Councilman Deterding reported that 88 tons of trash was collected in May along with 17 tons of recycling. Trash and recycling pick up will be a date late after the July 4th and Labor Day holidays.

RECREATION/L&I **COUNCILMAN MACFERREN**
 Councilman MacFerren reported that Licensing and Inspections collected \$7,687 last month.

INSURANCE/ENVIRONMENTAL **COUNCILMAN FLYNN**
 Councilman Flynn reported that there were no insurance claims in May. The Environmental Commission applied for bronze certification with Sustainable Jersey and thanks Maria Carrington for her assistance. Members of the Commission met with the DEP Forestry Service to discuss the Forestry Plan and possible funding opportunities. The Commission is also looking

into applying for a grant to help with tree removal due to damage by Southern Pine beetles. There has been lots of activity with the Community Garden. The first gardening clinic was held on May 26th attended by approximately 25 residents. Gardening methods were discussed as well as the Community Garden rules; garden plots were also selected. Sherwood Fencing Company supplied the low bid to fence the garden's perimeter. Due to the lack of plans regarding underground utilities, the fence posts will have to be installed by hand. NJ American Water awarded the Community Garden with a \$10,000 grant. There will be a formal opening of the garden and NJ American Water will be invited to attend. The goal of the garden is to be sustainable with no borough funding. There will be educational opportunities with a children's garden and programs on straw bale gardening, canning and preserves and rain barrels. A car wash and hoagie sale realized almost \$500. Another fund raiser on the 4th of July is being considered. A children's garden is also being investigated.

Mayor Campbell reported that the next issue of the Town Crier is being developed. On the Affordable Housing, E-consult has delivered a new set of gap requirements under the direction of the Superior Court. There is ongoing initiative to eliminate the gap period. Regarding Project Freedom, a package was mailed to the NJDEP in support of Project Freedom. Meetings have been ongoing with the property owners that will be acquired and should wrap up within a month or so.

Mayor Campbell noted that Maria Carrington passed the state exam and is now a Registered Municipal Clerk.

4. SUPERFUND/CAMDEN COUNTY – EPA will hold a public meeting on 6/21/16 on the proposed plan to clean up the Route 561 Dump Site. Camden County has hired Pete Fontaine, formerly Camden County Open Space Advisory Board, an environmental attorney and Andy Kricun, Executive Director of the Camden County MUA. Mayor Campbell met with them regarding the site. They are working with EPA and Sherwin Williams to accelerate the clean-up program. It was conveyed to them that if they try to divert resources to help Kirkwood Lake at the expense of the sites in Gibbsboro, we will fight them tooth and nail. Hopefully they will work with us and not become an obstacle. Mayor Campbell met with Sherwin Williams and the good news is they have awarded a contract to begin clean up of eight of the residential properties on West Clementon Road. They will be meeting with the residents. The residents will select fencing and landscape material. The Borough will determine what the process will be to monitor the work. Mayor Campbell met with the Construction Official to determine how he would like to manage the project. Property owners are being compensated in a number of different ways. The impacted residents should be pleased with the work that will be done.

A. NORCROSS LETTER – Mayor Campbell received a note at his house from Congressman Norcross’ office regarding his support of expediting the clean-up of Kirkwood Lake. The mayor talked to Norcross staff in both his Cherry Hill and Washington, D.C. office. This letter apparently originated from the Cherry Hill office.
