**NOW, THEREFORE, BE IT RESOLVED**, by the <u>Governing Body</u>, that the Year 34 Municipal CDBG Grant Agreement be adopted between the <u>Borough</u> of Gibbsboro and the County of Camden, a copy of the Agreement which is attached thereof; and

R.S. 52:27BB-52 - "A local officer or member of a local governing body who, after a date fixed for compliance, fails or refuses to obey an order of the Director of Local Government Services, under the provisions of this Article, shall be guilty of a misdemeanor and, upon conviction, may be fined not more than \$1,000 or imprisoned for not more than one year, or both, in addition shall forfeit his office."

2-12-7-79 RESOLUTION REQUESTING REVIEW AND APPROVAL OF AN AFFORDABLE HOUSING TRUST FUND SPENDING PLAN AMENDMENT DATED JULY 11, 2012

**WHEREAS**, the Borough of Gibbsboro adopted a development fee ordinance on April 12, 2006 and it was preliminarily approved by the Superior Court on April 17, 2006 and finally approved by COAH on August 2, 2006; and

WHEREAS, the development fee ordinance established an affordable housing

trust fund that includes development fees, payments from developers in lieu of constructing affordable units on-site, barrier free escrow funds, rental income, repayments from affordable housing program loans, recapture funds and proceeds from the sale of affordable units; and

WHEREAS, the Planning Board and Borough Council of the Borough of Gibbsboro, Camden County, adopted a third round Housing Element and Fair Share Plan, respectively, dated November 11, 2008 and submitted it to the NJ Superior Court for court review and approval on December 30, 2008; and

**WHEREAS,** *N.J.A.C.* 5:97-8.1(d) requires a municipality with an affordable housing trust fund to receive approval of a spending plan from COAH prior to expending funds in such account; and

**WHEREAS,** *N.J.A.C.* 5:97-8.10 requires a spending plan to include the following:

- 1. A projection of revenues anticipated from imposing fees on development, based on pending, approved and anticipated developments and historic development activity;
- 2. A projection of revenues anticipated from other sources, including payments in lieu of constructing affordable units on sites zoned for affordable housing, funds from the sale of units with extinguished controls, proceeds from the sale of affordable units, rental income, repayments from affordable housing program loans, and interest earned;
- 3. A description of the administrative mechanism that the municipality will use to collect and distribute revenues:
- 4. A description of the anticipated use of all affordable housing trust funds pursuant to *N.J.A.C.* 5:97-8.7, 8.8, and 8.9;
- 5. A schedule for the expenditure of all affordable housing trust funds;
- 6. If applicable, a schedule for the creation or rehabilitation of housing units;
- 7. A pro-forma statement of the anticipated costs and revenues associated with the development if the municipality envisions supporting or sponsoring public sector or non-profit construction of housing; and
- 8. A plan to spend the trust fund balance as of July 2008 within four years of the Council's approval of the spending plan, or in accordance with an implementation schedule approved by the Council;
- 9. A plan to spend and/or contractually commit all development fees and any payments in lieu of construction within three years of the end of the calendar year

in which funds are collected, but no later than the end of third round substantive certification period;

- 10. The manner through which the municipality will address any expected or unexpected shortfall if the anticipated revenues from development fees are not sufficient to implement the plan; and
- 11. A description of the anticipated use of excess affordable housing trust funds, in the event more funds than anticipated are collected, or projected funds exceed the amount necessary for satisfying the municipal affordable housing obligation.

**WHEREAS,** the Borough of Gibbsboro has prepared a spending plan amendment consistent with *N.J.A.C.* 5:97-8.10 and P.L. 2008, c.46 for pre-development surveying and engineering work of the Borough's affordable housing site, commonly known as Block 8.03; Lots 5, 6.01 and 6.05, as previously established in the Borough's Housing Element and Fair Share Plan.

**NOW THEREFORE BE IT RESOLVED** by the Borough Council of the Borough of Gibbsboro, Camden County, to request of COAH administrative review and approval of Gibbsboro Borough's spending plan, attached hereto.

Something to discuss at the September meeting is fireworks. Mayor Campbell commented that the Miss Gibbsboro Pageant was the best to date.

## POLICE/ENVIRONMENTAL COMMISSION

## COUNCILMAN CROGHAN

Councilman Croghan reported that there was a police vehicle accident and Patrolman Myers was slightly injured and is on light duty for a week. The insurance company is evaluating the police car. Councilman Croghan commented that he received an e-mail regarding speeders on Route 561. The Police Chief said he is aware of the problem. There are funds to purchase a new police car. The police committee will make a recommendation for a new vehicle at the next meeting.

#### COUNCILWOMAN MANCINI

Councilwoman Mancini reported that she and Roger Leonard, Risk Manager, will be addressing the loss control report as some of the items date by to 2002. Each location will be visited and pictures will be taken. The pictures will be sent to John Saville in an attempt to eliminate the problems. Most of the departments have dealt with the items on the list. The HIF forwarded a copy of their suggestions and recommendations. Gibbsboro has been invited to host classes in 2013.

#### L&I/ZONING BOARD

#### COUNCILWOMAN SCHIEBER

Councilwoman Schieber reported that the construction office issued 8 permits for June and total amount collected was \$817. In accordance with the Compliance Officer's report, Ray is keeping up with properties that need to be cut. Regarding the 4<sup>th</sup> of July "hot dog land", it went very well with many helpers including employees.

#### MAYOR'S REPORT

## MAYOR CAMPBELL

Mayor Campbell reported that a resident approached him at the Miss Gibbsboro Pageant and was non-stop on the accolades regarding the senior center. He called the senior center and Pole Hill Park a "hidden gem".

Councilman Bonsall commented that a couple of seniors have requested that a council person act as liaison with the seniors. Councilwoman Mancini volunteered to be liaison.

Mayor Campbell also reported that the path to Pole Hill Park has been cleared by Tri-Boro and that will be a good extension for the system. Berlin Road has been closed by the

County as the culvert collapsed. Kirkwood Road will be closed the week of 7/23/12 for sewer work from Farwood Road Hilliards Road. The statues at the Cricket Field are now lit at night. The renovations to the Charger Building are underway. A mold problem was discovered and the interior of the building had to be power washed.

The Mayor distributed a wetlands determination letter to Council from the NJDEP. The letter is in reference to the Tri-Boro tract. When the original sewer system was built, the Borough planned and was required to install a sewer system that could handle the Square Circle tract and the Tri-Boro tract. A lot of extra money was paid for capacity to deal with the two sites when they were developed. It is in the Borough's and the County's sewer plan. Camden County has recently revised their sewer plan based on State identification of sensitive lands and have taken that area out of their sewer service district which means there will no longer be capacity available for the sites. On one hand that's good, less housing, and on the other hand we're not in the situation as 10 years ago where there's no capacity in the school. Mayor Campbell believes Gibbsboro should protest and would like the authorization to continue to fight the battle. Council did not object.

There are a number of tax liens that the Borough holds from last year and at the August council meeting we will discuss the list and request authorization to foreclose.

The decorative street lights have been installed at Pole Hill Park. There are a number of dead trees on Route 561 – one fell by the CVS. Letters will be sent to the owners regarding removal of the dead trees.
