COUNCIL COMMITTEE REPORTS:

PLANNING BOARD/PUBLIC WORKS

COUNCILMAN BONSAALL

Councilman Bonsall reported that the Planning Board met last night. The update from COAH was discussed regarding the new guidelines. It is expected that this will require time to play out in the court. Regarding Public Works, the borough’s grounds continue to be maintained and clean up continues at the Lucas Homestead. The next focus will be on the fields. The Mayor commended Public Works on Lucas Park clean up.

PUBLIC EVENTS

COUNCILMAN BROWN

Councilman Brown reported that the Halloween parade is scheduled for Saturday, October 25, 2014. The 300th Committee met last night and decided to hold “Gibbsboro Day” on Saturday, November 1, 2014 from 10 a.m. to 2 p.m. The day will feature light snacks and music. Staff shirts with tercentennial logo will be sold and lapel pins will be given out free of charge. Photos will be taken of residents who fall into certain categories such as youngest resident, most senior

resident, and residents who have lived in town for 50 years or more. There will also be a ribbon cutting on the bike path.

POLICE/LIBRARY

COUNCILMAN CROGHAN

Councilman Croghan reported that there is nothing to add to the police report. For the library, it was reported that 51 patrons used the library in July and 30 patrons used the library in August. Even if the same patron comes more than once a month, the patron will only be counted once.

TRASH

COUNCILMAN DETERDING

Councilman Deterding reported 18.5 tons of recyclables was collected in August and a rebate check amounting to \$279 was received. There was no tonnage report available yet for August's trash.

INSURANCE/RECREATION/L&I

COUNCILMAN MACFERREN

For Insurance, there was nothing to report. Councilman MacFerren reported that for Recreation he is meeting with representatives from playground suppliers to determine what equipment should be purchased with the \$25,000 grant money received from the County for Lauer Park. There was no report for L&I.

LOCAL ASSISTANCE/ENVIRONMENTAL

COUNCILMAN FLYNN

Councilman Flynn reported that for Local Assistance, there is one active disability claim still waiting for classification. For Environmental, Councilman Flynn is working on the update to the Shade Tree compliance and will be attending training in late October. He will most likely bring Public Works with him to attend the training. He is currently receiving bids for the Tercentennial Colorado Blue Spruce tree and considering a non-fruit producing alternative tree to replace the apple tree on Foster Avenue.

MAYOR'S REPORT

MAYOR CAMPBELL

Mayor Campbell reported that the sewer slip lining on Haddon Ave and Farwood Road is finished thus completing our sewer project. Super Jet construction will be continuing after correct drawings are submitted. An application to Camden County for \$50,000 to restore the Lucas Homestead has been submitted. Turner Tree has completed the tree work around the borough. Bids have been received for the trash contract. Chad Gunther Memorial Fund will donate \$6,000 for the score boards at Cricket Field and would like put signage on the score boards. Their fundraiser is this Saturday. We have received formal notice that Gibbsboro will be receiving \$50,000 in recreation grants: \$25,000 to put in concrete on Berlin Road bikeway and \$25,000 for the playground equipment at Lauer Park. The street resurfacing of Clementon Road and Foster Avenue has been completed by the County and Kirkwood Road is slated for resurfacing next year. New Jersey American Water needs to repair the damage that they caused to the curbing on the triangle on Clementon Road.

1. SOLID WASTE AND RECYCLABLE COLLECTION BIDS

Bids received Gold Medal Environmental of NJ, Inc. and Waste Management of NJ, Inc.

See attached recommendation from Engineer Greg Fusco. Mr. Fusco recommends awarding to Gold Medal Environmental of NJ, Inc. for low bid Option #1, 5 years for collection of solid waste for one day per week in the amount of \$311,840 and Option #3 single stream recycling in the amount of \$229,782 for a total of \$541,622.

Two bids were received. The low bid from Gold Medal Environment is pretty consistent with our current contract. Discussion was held whether there should be a second day of trash pick-up on Saturdays of the summer. It was decided that one day of pick-up was sufficient and saves the Borough money as less than 20% of residents may have used the service and no complaints were received when the second pick up day was discontinued.

Mr. Jim Sage of Gold Medal Environmental addressed the council. He gave an overview of his company and experience. Mr. Sage stated that trash collection would start at 7 a.m. on Tuesdays. It is expected that pick-up will take 6 to 6½ hours. Once they have a clear understanding of the tonnage involved, they will try using a split truck to collect solid waste and recycling at the same time expecting that two hauls will be necessary. Gold Medal will help with communicating to the public regarding the split truck concept so that residents do not think that their recycling is being combined with the solid waste. Gold Medal promised a list, in advance, of any collection date changes due to holidays.
