**COUNCILMAN BONSALL**

The Planning Board did not meet in December. Councilman Bonsall reported that the second leaf collection is underway. Borough is looking to purchase equipment for the roads department.

**COUNCILMAN BROWN**

Councilman Brown reported that the rain and electrical issues did not dampen spirits at the annual Tree Lighting festivities held at the school. He thanked the school for letting the borough use the gym, Kathy Mitchell and the Eastern Jazz Band for performing, McMillan's for the cookies and the Fire Department for its continued support of the event. Letters will be drafted to thank the above groups for their participation.

Councilman Croghan reported that the library has priced some old books for sale. Councilman Croghan commented that the Police did a good presentation at the Town Watch meeting. Councilman Croghan stated that the police may need two additional officers in the new year as well as another police vehicle.

**TRASH/RECYCLING**

**COUNCILMAN DETERDING**

Councilman Deterding reported that the trash collection is going well and there have been no future reports of alleged trash and recycling commingling. In November 77 tons of trash were collected. There was no recycling report.

**RECREATION/L&I**

**COUNCILMAN MACFERREN**

No report due to Councilman MacFerren's absence. Councilman Deterding did bring up the issue of purchasing benches for Blueberry Hill should grant funding become available.

**INSURANCE/ENVIRONMENTAL**

**COUNCILMAN FLYNN**

Councilman Flynn reported that there were no insurance claims in November. Regarding the Environmental Commission, they are working on new sustainability projects and plans to apply for certification with Sustainable Jersey in June of 2016. In addition, a committee is working on plans to build and fund a community garden. A blue print should soon be completed to lay out the area and then public outreach will begin. Fencing and irrigation issues are being investigated. Councilman Flynn has also been in contact with an arborist to help the commission identify tree problems.

**MAYOR’S REPORT**

**MAYOR CAMPBELL**

Mayor Campbell reported that the borough had a bond sale today and received a winning bid of 2.493557% interest rating which will have minimal impact on the tax rate. It will be retired within ten years. Robert W. Bair was the low bidder. This is a great rate and was achievable due to the superior rating of AA+ received by Standard and Poor’s which is higher than the county, state and federal governments. A FEMA reimbursement check of almost \$5,400 has been received to cover costs associated with the June 23<sup>rd</sup> storm.

There is a grant opportunity for the fire company to purchase trucks and generators. Councilman Bonsall made a motion to authorize hours for the Borough Engineer to work the Fire Chief to submit a grant application. Seconded by Councilman Flynn.

Super jet is moving ahead slowly. Mayor Campbell met with the realtor of the Frasca Property on Lakeview Drive to discuss possible uses. Neighborhood Watch signs have been ordered. In discussions with the Tax Assessor, it seems that the tax reassessment is on the horizon. A reassessment will require a tax map update so now is the time to consider some deed consolidations. Work to install the HVAC unit at the scout building should be starting in the next week or two. Fencing by the bikeway bridge on 561 has been installed which should last 25 years. The split rail fence used near Blueberry Hill requires replacement every six months. DEP has submitted a report on the Clements Lake Dam. Sherwin-Williams is willing to do the dam work while performing Superfund clean-up work of the burn site.
