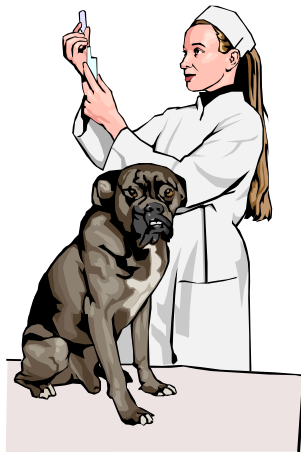

On Tuesday, July 30, 2013, Legionnaire Tom Daly became mobile after a long bout with an inability to walk. But on this day, Gibbsboro Post 371 Commander, Joe Hammell, and First Vice Commander, Sonny Hamilton, delivered this handsome motorized scooter (shown) to three-year member Tom Daly.

“It’s part of our **WHEELS FOR VETS PROGRAM** and just a beginning of making many handicapped veterans happy again with the ability to get around and be active”, says Cmdr. Hammell.

Member John Cheesebro, Daly’s neighbor in Legacy of Waterford Pines, Atco, notified the Legion Board of the need at hand. As luck (or fate) had it, the electric scooter had just been donated to Post 371 by a 96 year old Legionnaire who wanted someone else to benefit by it. “The \$1200-valued beauty required only a battery” said Hammell, “so we cleaned and polished her up to make her new again”.

Post 371 also has ten (10) wheelchairs ready for the next batch of buddies needing them as part of this program.

Tom Daly says of his new wheels, “...it’s a life-changer for sure. Now I can actually take my dog for a walk!”. Over exposure to asbestos has deemed Tom unable to take enough breath, even with 24/7 oxygen, to also walk, “can’t do BOTH at the same time!”, says this U.S. Coast Guard Veteran of 1952-1956.

The Gibbsboro American Legion Post 371 **WHEELS FOR VETS PROGRAM** should be an inspiration to many Posts around the Country as more and more veterans become incapacitated.

## **PAINTWORKS STACKS RE-POINTED**



Brandywine Realty Trust recently completed restoration work on the chimneys (stacks) near Lakeside Manor on Silver Lake. The chimneys date to the 1880’s and are among the last remnants of the John Lucas Company’s paint manufacturing plant that operated in Gibbsboro until 1978. The stacks are protected by Gibbsboro’s Historic Preservation Ordinance.

Permits have also been issued for the restoration of the decking along the dam of the lake. That work will begin in the next few months.

# Pet Waste Pollutes Our Waters

---

## *What You Can Do To Help Protect Our Water*

---

Clean and plentiful water is important to our families, our environment, our economy and our quality of life.

Did you know that animal waste from pets can pollute our waters? When left on the ground, pet waste is washed by rain and melting snow and ice into storm drains that carry it to our rivers, lakes, the ocean and drinking water.

Animal waste contains a high concentration of nutrients as well as bacteria and disease-causing microorganisms that can cause problems.

### **What you can do**

Pet owners or anyone who takes your pet for walks must properly dispose of the waste by picking it up, wrapping it and either placing it in the trash or flushing it unwrapped down the toilet.

Your municipality is required to adopt and enforce local pet-waste laws. At a minimum, your community must require that pet owners or their keepers **immediately and properly** dispose of their pet's solid waste deposited on **any public or private property not owned or possessed by that person**. People with assistance animals such as Seeing Eye dogs are exempt.

Make sure you know what your municipality requires – and follow it.

Thank you for doing your part to keep New Jersey's waters clean.

## **Atlantic City Electric Advises Customers to Avoid the “Green Dot” Scam** *Always Check for Proper Identification*

Atlantic City Electric reminds home and business owners to practice safety when someone claiming to represent a business contacts them either in person or by telephone. Recently, Atlantic City Electric has been alerted to a “Green Dot” scam. As such, information from law enforcement officials and other utilities has indicated that “scammers” are targeting not only residents, but also commercial businesses. It has been reported that “scammers” are telling business owners that the location's electric service account is delinquent and it will be shut-off for non-payment unless the business purchases a "Green Dot Money Pack" for a specific amount dictated by the “scammer” from stores including CVS, Rite Aid and WaWa. Victims are then given instructions to call a “scammer” telephone number with the card's account number and pin. Once the “scammer” obtains the card's identifying information, the value is then downloaded, swept and stolen. These transactions are untraceable.

Many companies, including Atlantic City Electric, will contact customers in person or via phone for various reasons. If someone claims to represent a company, whether the company is Atlantic City Electric or another entity, it is important that customers take precautions to verify the person is affiliated with the company, especially if that person is requesting an immediate monetary payment.

When addressing past due accounts Atlantic City Electric never endorses a specific form of payment. Instead, multiple payment options are always given to the customer.

Atlantic City Electric advises customers to ask for official photo identification from any person who shows up at their door. Employees from reputable companies, such as Atlantic City Electric, will carry official company identification cards. If proper identification cannot be produced, customers should notify police and the company with whom the individual claims to be associated. Similarly, if someone calls saying they represent a certain company, customers should ask them to verify their identity and affiliation. If customers have any doubt about the validity of a person's claim to represent Atlantic City Electric, they should call the company immediately at 1-800-642-3780.

## Police Blotter January 2014

On January 13 officers were dispatched to Henry Road for a domestic disturbance. Upon arrival both parties stated that they were engaged in a verbal exchange. After a police investigation no complaints were signed.

On January 15 officers were dispatched to Kingsbridge Road for a report of a break in. The officers made way into the residence to make sure no one was hiding. After clearing the residence, a family member looking after the house was notified of the break in. Neighbors were questioned - one neighbor reported a suspicious person around the area described as a white male with dirty blonde beard, black gloves, smoking a cigarette, wearing a knit style hat and a light tan / light blue flannel shirt walking in the area.
