### **Small Towns Lobby Hard for Reversal of State Cuts**

**Gibbsboro among leaders in the fight for funding.**

Leaders in small towns around New Jersey have been lobbying Trenton for the restoration of proposed municipal aid cuts that would eliminate Consolidated Municipal Property Tax Relief Aid (CMPTRA) for all municipalities with a population of under 5,000 (194 municipalities) and cut it in half for municipalities with a population between 5,000 and 10,000 (136 municipalities). Gibbsboro's estimated 2006 population is 2,451. CMPTRA will also be reduced for larger towns, but not anywhere near as much as proposed for small towns. All towns will also lose Municipal Homeland Security Assistance. **Gibbsboro stands to lose more than \$158,294 in CMPTRA and Municipal Homeland Security Assistance and \$125,000 in extraordinary aid!** These cuts will make small towns less desirable as they will result in larger property tax increases.

Gibbsboro has been featured on the front page of major newspapers including the Washington Post and on a BBC radio talk show in London. Mayor Campbell has testified before the Assembly Budget Committee on the topic and written numerous Op-Ed articles in New Jersey magazines and newspapers. Council has passed numerous resolutions in opposition to various proposals and is also lobbying the legislature.

### Affordable Housing Update

The New Jersey Appeals Court has scheduled oral arguments in connection with Fair Share Housing Center's (FSHC) appeal of Gibbsboro's second round Housing Plan. Under the Borough's plan Woodlynne will rehabilitate 56 units of housing earmarked for low and moderate income families within Woodlynne. Gibbsboro will pay Woodlynne \$25 thousand for each of the 56 units. That will satisfy 50% of Gibbsboro's first and second round housing obligation, and represents the maximum that can be transferred to another town.

COAH recently adopted a number of Third Round Affordable Housing rules with which municipalities will be required to comply. Court challenges are expected from municipalities and affordable housing groups. COAH will be proposing amendments to a number of third round rules based upon more than 4,000 comments submitted by builders, housing advocacy groups, and municipalities. As the rules evolve Gibbsboro will be required to prepare a revised Affordable Housing Plan that meets the new rules. A major change is that towns will be required to meet established housing goals based upon forecast growth data or actual development.

### NJ Department of Transportation (DOT) Awards Gibbsboro \$200K for Streetscape

NJ DOT Commissioner Kris Kolluri recently announced that Gibbsboro will receive a \$200 thousand discretionary award from the department for the town's Streetscape project. The Streetscape will further the evolving motif that is developing on the Lakeview Drive (aka Haddonfield-Berlin Road) corridor. Plans include adding more period style lights, the "Gibbsboro Wall", complementary landscaping, and an eight feet wide bikeway/sidewalk. The project will run from the light at Lucas Boulevard to Wachovia Bank along the Cricket Field side of 561 then down Clementon Road to the intersection at Foster Avenue on the Paintworks side of Clementon Road.

The project will complete a five mile long trail/bikeway along the eastern side of Gibbsboro that includes links to Eastern High School, Lindenwold Park, and the Paintworks Corporate Center. The project is expected to be competitively bid this summer with construction beginning this fall.

### Environmental Commission Champions Successful Spring Cleaning

Early on Saturday morning, May 3<sup>rd</sup> dozens of volunteers gathered at the Gibbsboro Fire Company to form into teams to collect trash around town. Volunteers included a strong showing from the Environmental Commission, the Wynnewood development, students from all three towns at Eastern Regional High School, and other residents. They collected trash from Hilliards, Clementon, and Kirkwood roads, Route 561, as well as along parts of our bikeway system. It was the most successful clean up day in memory. Our thanks to those who gave their time to putting a shine on our town!

## Senior Citizens' Legal Workshops Summer 2008 Events Calendar

Free Senior Citizen Legal Workshops are planned for the Camden County Store at the Echelon Mall in Voorhees. These workshops, sponsored by the Camden County Board of Freeholders and cooperating agencies, enable Camden County residents **60 and over** to acquire free, at no cost, a Last Will and Testament, an Advance Directive for Health Care (Living Will), and a Power of Attorney.

**Advance Directive for Health Care (Living Will)** Participants who wish to prepare an Advance Directive for Health Care (Living Will), will need to provide their name, address, phone number and the names and addresses of their health care representatives.

**Last Will and Testament** Participants who wish to prepare a Last Will and Testament, will need to provide the lawyer with the following: name, address, phone number, executor, alternate executor, cash bequests, and the names of the residuary and successor beneficiaries of their estate. **Please note that the wills prepared through this program are conventional (simple) wills. We do not do wills for people who need life estates, trusts, guardianships or that exclude spouses.**

**Power of Attorney** Participants who wish to prepare a Power of Attorney will need to provide the following: name, address, phone number, social security number, the names, addresses and phone number of their appointed agent and alternate agent.
