# **Gibbsboro Fire Company**

Volunteerism is down nationally and local volunteer fire companies are suffering. Every year there are stories of volunteer fire companies that are shut down due to a lack of volunteers. Recently, this just occurred right here in Camden County, New Jersey. The Cedar Brook Fire Company is one of several which are part of the Winslow Township Fire District. Their fire station was just shut down because there were only six (6) volunteer firefighters remaining. With the closing, ninety-seven (97) years of volunteerism at Cedar Brook Fire Company is **GONE**!

Gibbsboro Fire Company has been in existence for 91 years as a purely volunteer fire company. We are also feeling the shortage of volunteers and have an aging problem as our average age is currently fifty-four (54). Gibbsboro only has one fire station in town and should this happen here, we would have to rely on another town for fire protection. What does this mean for residents? Increased response times, increased taxes, as our neighboring fire companies have fully paid staff or are fire districts which tax separately from the town. Some of the long-standing traditions would come to an end like the way we take Santa around town.

We desperately need individuals to join the ranks of the fire company. Join us today and become something bigger by being part of a dedicated team helping those in need. No experience is necessary as we provide all training and equipment. ## **Success - Earth Week Spring Clean Up!**

On Saturday April 24, led by the Gibbsboro Environmental Commission, roughly 50 volunteers including the local boy scout troop collected trash from around town including the Borough's trail system. Several dozen bags of paper, bottles and cans were removed from roadsides and throughout open space.

#### Take Note: Don't Feed the Waterfowl!

Chapter § 96-18 **Feeding prohibited.** It shall be unlawful for any person to feed, cause to be fed, or provide food for wild water fowl or to create any condition or allow any condition to exist which results in a threat to the health, safety or welfare of wild water fowl and migratory water fowl.

Minimum Fine: \$100.

#### Dear Residents and Business Owners:

In accordance with the Borough's Tier A Municipal Storm Water General Permit, the Governing Body has adopted various ordinances to regulate the impact of storm water and pollutants on the environment. As part of our required Local Public Education Program, we are sending this letter to you annually to highlight the requirements and environmental benefits of these Ordinances. The following describes the Ordinances in the Municipal Code:

- 1. <u>Pet Waste</u>: This Ordinance <u>requires</u> all pet owners to pick up and properly dispose of pet waste dropped on public or private property. This requirement prevents fecal contamination from impacting our local waterways.
- 2. <u>Litter</u>: This Ordinance states that it is unlawful to throw, drop, discard, or otherwise place litter of any nature on any public or private property, other than a litter receptacle. This requirement has been adopted to prevent all types of litter from cluttering public streets and private property and prevents litter from impacting our waterways.
- 3. <u>Improper Disposal of Waste</u>: This Ordinance states that it is illegal to dispose of waste in any place other than a proper solid waste storage container. The purpose of this Ordinance is to prevent unsanitary conditions and groundwater pollution.
- 4. <u>Wildlife Feeding</u>: Feeding of water fowl on municipal park land or property is prohibited by Ordinance. The purpose of this Ordinance is to reduce water fowl population in response to health concerns regarding bacteria from fecal matter which is harmful to humans and fish populations. Also, § 96-18 extends the prohibition to the entire community. It states "It shall be unlawful for any person to feed, cause to be fed, or provide food for wild water fowl or to create any condition or allow any condition to exist which results in a threat to the health, safety or welfare of wild water fowl and migratory water fowl."
- 5. <u>Yard Waste</u>: This Ordinance has been created to establish a system for the placement and collection of leaves, brush, and other yard wastes. The purpose of the Ordinance is to keep leaves, grass and other yard waste out of the storm water inlets and piping, and ultimately out of our waterways.
- 6. <u>Illicit Connections</u>: It is unlawful to connect any pipe or discharge to the municipal storm sewer system that is intended to discard, spill, or dump any substance other than storm water or groundwater (via sump discharge) into the system. The purpose of this Ordinance is to prevent contamination of our streams and waterways which receive discharge from our storm sewers.

The transport of pollutants into local streams and water bodies can result in the destruction of fish, wildlife, and habitats; threats to public health and the loss of recreational and aesthetic value.

The Governing Body has enacted the above listed Ordinances to protect our environment, and to keep pollutants that are commonly conveyed by storm water from adversely impacting our waterways and groundwater supplies. 

#### WE REMEMBER: JOSEPH EDWARD LAUER

December 19, 1948 - May 31, 1968



JOSEPH EDWARD LAUER was a member of the Class of 1967, the first graduating class of Eastern Regional High School. After graduating from Eastern, Lauer enlisted in the US Marine Corps and volunteered to go to Vietnam.

Lauer's duty started on May 8, 1968 and only 23 days after arriving in Vietnam, Private First Class Lauer, on May 31, 1968, at the age of 19, was tragically killed in Quang Tri, South Vietnam, the result of hostile mortar fire. He was awarded the Purple Heart.
