ORDINANCES FOR SECOND READING

ORDINANCE VACATING A PORTION OF TROTH AVENUE IN THE 2023-06 **BOROUGH OF GIBBSBORO**

WHEREAS, the Gibbsboro Borough Combined Land Use Board by Resolution PB2023-

3-10 has granted site plan approval to Gibbsboro Car Wash, LLC for the redevelopment of the former Masso's Deli property known as Block 7.04, Lots 19.12, 19.13, 19.14 (also known as No. 11 North Lakeview Drive); and

WHEREAS, the Combined Land Use Board granted site plan approval contingent upon the applicant making a request to the Governing Body of the Borough of Gibbsboro to vacate the right-of-way of Troth Avenue being 50 feet wide with an improved 25 feet wide bituminous cartway that intersects with North Lakeview Drive and terminates with the paper street known as Lucas Boulevard as shown on Sheet No. 4 of the Official Borough of Gibbsboro Tax Map; and

WHEREAS, The Governing Body has reviewed the vacation request and has determined that it is in the best interest of the Borough of Gibbsboro, as well as the Gibbsboro Car Wash, LLC, to grant the request for vacation subject to certain conditions, limits and easements; and

WHEREAS, the conditions, limits and easements associated with the vacation are as follows:

- 1. The vacation of Troth Avenue shall take place from the intersection of the right-of-way of North Lakeview Drive to the location of the property line common with Block 7.04, Lots 19.14 and 19.15, and the extension thereof.
- 2. The portion of the vacated Troth Avenue right-of-way adjacent to block 7.04 lot 16.02 (a.k.a. the Cricket Field) shall be 14.00 feet in width and retained by the Borough of Gibbsboro. The remaining area between the former centerline of the Troth Avenue right-of-way and its resulting northwesterly lot line with lot 16.01 shall be conveyed to Gibbsboro Car Wash, LLC by way of a quitclaim deed from the Borough of Gibbsboro and consolidated with the lots included in the Gibbsboro Car Wash, LLC site plan approval.
- 3. Gibbsboro Car Wash, LLC shall prepare, at its sole expense and subject to the approval of the Borough Engineer and Solicitor, an easement providing the following:
 - a. The Borough of Gibbsboro and general public shall have uninterrupted, continuous, and perpetual cross access across and through the 25 feet driveway area shown on the site plan approved by the Combined Planning Board and said driveway shall remain in place for said access in perpetuity.
 - b. Gibbsboro Car Wash, LLC and any and all future property owners shall grant uninterrupted, continuous, and perpetual access easements for the maintenance, repair, replacement and operation of all above grade and below grade existing and proposed underground utility mains for gas, sewer, water, storm sewer, electric, etc. All rights and privileges now possessed by any public utility or cable television company, to maintain, repair and/or replace their existing facilities in, adjacent, over or under the vacated portion of Troth Avenue are hereby expressly reserved and excepted from this vacation.
 - c. Gibbsboro Car Wash, LLC and any and all future property owners shall be responsible for maintaining the pavement cross section within the 25 feet driveway area noted in Item Number 4 and as described in Item Number 1 above.

NOW, THEREFORE, BE IT ORDAINED by the Mayor and Council of the Borough of Gibbsboro, County of Camden, State of New Jersey that the vacation of Troth Avenue from the

intersection of North Lakeview Drive to the location common with the property line between Lots 19.14 and 19.15, and the extension thereof., is hereby authorized subject to the conditions in this ordinance; and

BE IF FURTHER ORDAINED that all ordinances contrary to the provisions of this ordinance are hereby repealed to the extent that they are consistent herewith, and that this ordinance shall take effect upon passage, publication according to law, and the preparation and filing of the easement required by this ordinance.

Section 2. All such bond anticipation notes shall mature at such times as may be determined by the Chief Financial Officer, provided that no bond anticipation note shall mature stated and later than one year from its date; unless such bond anticipation notes are permitted to mature at such later date in accordance with applicable law. All such bond anticipation notes shall bear interest at such rate or rates as may be determined by the Chief Financial Officer. The Chief Financial Officer shall determine all matters in connection with bond anticipation notes issued pursuant to the Bond Ordinances, and the Chief Financial Officer's signature upon such bond

anticipation notes shall be conclusive evidence as to all such determinations. All such bond anticipation notes may be renewed from time to time subject to the provisions of the Local Bond Law or other applicable law.

Section 3. The Chief Financial Officer is hereby authorized to sell part or all of the bond anticipation notes from time to time at public or private sale and to deliver them to the purchasers thereof upon receipt of payment of the purchase price plus accrued interest from their dates to the date of delivery thereof. The Chief Financial Officer is directed to report in writing to the governing body at the meeting next succeeding the date when any sale or delivery of the bond anticipation notes is made. Such report must include the amount, the description, the interest rate and the maturity schedule of the bond anticipation notes sold, the price obtained and the name of the purchaser.

Section 4. The Chief Financial Officer of the Borough is hereby authorized to prepare and to update from time to time as necessary a financial disclosure document to be distributed in connection with the sale of the bond anticipation notes and to execute such disclosure document on behalf of the Borough. The Chief Financial Officer is further authorized to enter into the appropriate undertaking to provide secondary market disclosure on behalf of the Borough pursuant to Rule 15c2-12 of the Securities and Exchange Commission (the "Rule") for the benefit of holders and beneficial owners of bond anticipation notes of the Borough and to amend such undertaking from time to time in connection with any change in law, or interpretation thereof, provided such undertaking is and continues to be, in the opinion of a nationally recognized bond counsel, consistent with the requirements of the Rule. In the event that the Borough fails to comply with its undertaking, the Borough shall not be liable for any monetary damages, and the remedy shall be limited to specific performance of the undertaking.

Section 5. This resolution shall take effect immediately.
