Planner Review Letter, dated 10/17/23

Peter Jacanian, Esquire, appeared on behalf of this application, along with John Scorsone, president of Solare America LLC. Mr. Scorsone was sworn in by Ms. Gaskill, as was the Board Planner, Mr. Slaugh.

The applicant proposes to install 190 solar panels on the fuel canopy at the Wawa located at 3 North Lakeview Drive. Mr. Scorsone testified that 94 panels would be placed along the Lakeview Drive side of the canopy, and 96 panels would be placed on the store side of the canopy. The panels would be parallel to the surface of the roof, and they will be black. The panels will be owned by Solare America, and Wawa will purchase the energy produced as part of a 25-year lease agreement. At the end of the lease period, ownership of the panels will be transferred to Wawa.

The Board requested that the panel arrangement be reversed so that the 94 panels and ACP unit be placed on the store side, and the 96 panels be placed on the street side, and the applicant agreed to this request. Mr. Slaugh also noted that if a gap was visible between the panels and the edge of the canopy, that an array skirt would be required, as has been required of other solar panel applicants in the Historic Preservation District.
