ORDINANCES FOR SECOND READING

2022-10 ORDINANCE AMENDING CHAPTER 171 OF THE CODE BOOK OF THE BOROUGH OF GIBBSBORO ENTITLED "VEHICLES AND TRAFFIC"

The Mayor and Borough Council of the Borough of Gibbsboro having determined that in the interest of public safety and for the efficient disposition of traffic violations;

SECTION 1. Therefore, Be It Ordained by the Mayor and Borough Council of the Borough of Gibbsboro that sections of Chapter 171 shall be amended as follows:

§ 171-3 Violations and penalties.

- A. Unless another penalty is expressly provided by New Jersey statute or within Chapter 171, every person convicted of a violation of a provision of this chapter or any supplement thereto, other than handicapped parking, shall be liable to pay a fine of \$50 for each offense.
- B. Any person parking in a space reserved for handicapped individuals shall be liable to pay a fine of \$250 for a first offense, and a fine of \$250 plus a maximum of 90 days community service for all subsequent offenses.

§ 171-28 Designation of snow emergency no-parking areas.

A. Whenever snow has fallen or ice has formed on a road surface and the accumulation is such that it covers a street or highway, an emergency shall be deemed to exist and no vehicle shall be parked on any streets in the Borough, whether paved or unpaved, or portion thereof.

B. The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed or sufficiently treated to the extent that parking will not interfere with snow removal, roadway treatment operations, or the normal flow of traffic.

§ 171-29 Designation of other emergencies; Posting of signs.

- A. The Chief of Police, or in his absence, the ranking police officer, is authorized to declare an emergency when other weather conditions, accidents, fires or public celebrations dictate or require the avoidance of hazards or other conditions which interfere with the free flow of traffic.
- B. Upon the declaration of an emergency, there shall be no parking upon streets or parts of streets where temporary emergency no-parking signs are displayed.
- C. Notification that the emergency no-parking signs are being or will be posted shall be given to the operator or owner of any vehicle which has been parked prior to the posting of the signs.

SECTION 2. All ordinances or parts of ordinances which are inconsistent with the provisions hereof are, to the extent of such inconsistencies, hereby repealed.

SECTION 3. This ordinance shall take effect upon final passage, adoption, and publication in the manner prescribed by law.
